Monthly Summary

Many of the areas patrolled revealed new and fresh snaring activities. This increase can be attributed to several reasons, many of which are interconnected. The most obvious reason is a result of the drought. Poverty is another major contributor to increased poaching. And finally escalated food prices ties in with high level of unemployment, illiteracy and misuse of natural resources.

Mwatate sisal estate was visited as a follow up and yielded the highest number of snares lifted from all areas covered during the month. The wild animals living in this plantation are vulnerable to becoming poaching victims due to the snares, as there's a high human population living around and work in that area.

Taita hills wildlife sanctuary and Lualenyi ranch was also visited as a follow up. This has been a very important migratory corridor of animals moving from Tsavo West National Park to Mgeno ranch and on to Tsavo East National Park. The team increased patrols in this area to make sure that animals are safe while feeding and moving around to other areas. A snared domestic cow carcass was found and logging and charcoal burning are the other major illegal activites taking place there.

The area around Lion hill just bordering the Park access road towards Voi Safari Lodge and Irima area also had plenty of poaching taking place. The Team found freshly laid snares targeting impalas and waterbuck which are very common in this area. The team will visit again the area next month to monitor the situation on the ground.

On the southern side of the Tsavo East National Park, the team patrolled Kulalu Ranch following many snares have been lifted last month in that area. Cattle grazing was sighted as a major problem taking place there with 500 heads of cattle were driven out of the park, on the other side of Kudu area towards Voi River the team trek three bicycles marks for more than ten kilometers and found a recently used poacher's hideout as well as a fresh elephant carcass with its tusks having been cut off.

During patrols in Dakota ranch, many snares targeting small game were lifted and a poacher evaded arrest after seeing the Team from a distance. He escaped, leaving behind personal belongings and five dikdik carcasses, and a panga. The team also came across an eland calf which was about three days old lying alone on the road, it became obvious the calf had eye problems and its possible his mother abandoned him due to this disability. The orphan was taken to the Trust's Voi orphanage.
