#### De-Snaring Report for June, 2012

#### **Monthly Summary**

The team visited Ngutuni ranch in the first week of the month to make sure that the wildlife on the ranch are safe place from being snared. The team noted that many herds of elephants have migrated to the area due to the availability of water, while many parts of Tsavo East National Park have experience a persistent drought. Cases of livestock grazing and charcoal burning have been sighted as a major problem taking place there. Patrols in Teri ranch saw no major illegal activities taking place. So the team extended its patrols to Lualenyi ranch whereby five big snares were lifted and a giraffe carcass was found which is believed to have died naturally. The team then moved on to Mbulia ranch which was as it is known for being a snaring hotspot. The majority of the snares lifted in June were found on this ranch. The team has discovered that many of the snares in the Ranch are set by the casual workers of the Kenya power line which is being constructed along the Mombasa/Nairobi highway; lots of snares were lifted near their camps.
