#### **Monthly Summary**

The teams operation started on the 18th of November as the Team was off duty from the 3rd of Nov -18th of Nov. De-snaring I ranch which is normally a poaching hotspot. Snaring and charcoal burning were the two major illegal activities taking place the poacher in possession of about 1kg of squirrels, a small hand held catapult, and seven big snares; he was booked at Voi polic

On patrolling the Mbulia park boundary, the Team got information of the whereabouts of poacher's entry and exit routes which Team found many freshly laid snares and a Dikdik carcass as evidence to back this information. An ambush was organized a rested as he came to check on his snares. The poacher was arrested with being possession of twenty seven snares targetin catapult. He was also booked at Voi police station.

When visiting Sagalla ranch, the team noted that poaching and charcoal burning activities which up until now have been high, seems that persistent patrols and keeping up the pressure of patrols in the last six months has finally yielded positive results. I inactive snares.

On the 2nd and 3rd day of November, the team organized two ecological field trips to Tsavo East National Park. The two scho educational field trip were Mwambiti primary school and Miasenyi primary school. The pupils saw herds of elephants, buffaloes other antelopes. The primary objective of this project is to make this community an integral part of our conservation effort by se conservation. The pupils also visited the Voi Elephant orphanage whereby they got the opportunity to interact with the baby ele as get a educational lecture from the elephant Keepers.
