Monthly Summary

The protection of Kibwezi forest is beginning to look effective. For the first time since the Team began its patrols of the Forest, was noticed during in the month of august. However near Kibwezi town, 28 snares were lifted targeting medium/large game su carcass was found having been killed by arrowing. The team intends to visit this area regularly. Many wild animals, especially I sighted regularly in the Kibwezi forest. Fire wood collectors who come in to harvet wood must be made aware of their presence must be zoned to avoid injuries and further human-wildlife conflict.

The Wood carving business poses a threat to the Chyulu ecosystem. This month the Team arrested 2 groups in possesion of of the groups had over 800 pieces in their possesion. Most of the wood carvers are felling trees for this use and as a result la

The groups of wood carvers operating in groups of 2 to 20 people have been confronted during this month aloe, showing the r Children are being used as porters to assist with supplying the carvers with water and food and are discouraged from going to

The use of mobile phones for communication with charcoal dealers and wood carving buyers at Nairobi or Mbui nzau is our gre has established a good intelligence and information network aimed at apprehending the culprits. As it is dry there are bush fires occuring. Fires have been used by poachers for getting rid of the old grass and then entice the fresh grass germinates.
