DE-SNARING REPORT DECEMBER 2013 CHYULU/DUMA TEAM



#### Chyulu/Duma Team Patrol Report for December, 2013

#### **Monthly Summary**

The Chyulu Team lead by Stephen M, focused their operations inside the Chyuku National Park and its surrounding communities during December. The team arrested and booked 22 people who they captured while on patrol. The majority of incidents this month involved cases of illegal grazing within the Chyulu Hills NP. Additional cases included charcoal production, woodcarving, logging and growing of miraa and game-meat processing.

The Chyulu Team focused on the illegal cattle entering the Chyulu Hills NP, arresting 22 herders




Like other teams the Chyulu Team is always on the lookout for wildlife sightings within their area. This month they spotted two lionesses out on the open on the hills sides of the Chyulu Hills – a good sign that the intruding cattle have not pushed the lion out.

A lioness, often victims of poisoning by cattle herders, sighted on the open hillsides of the Chyulu Hills



Two persons were captured and charged with the processing of game-meat, one of the ongoing threats to the wildlife of the Chyulu Hills NP which has a long running unfenced border with communities. Two people were charged with cutting trees and taking illegal wood from the park.






KWS rangers and the Chyulu Team capture a wood carver in the Chyulu Hills NP  $\,$ 



While the forested Chyulu Hills NP tends to have many cases of illegal loggers and wood-carvers, the bush-meat trade here also flourishes. The main quarry is Coke' Hartebeests which are chased down on foot into areas where they become trapped by the terrain. The animal is then slashed on the back of the legs by whoever can get close enough to immobilize it, before the *pangas* close in and finish it off. The team does not find large numbers of snares like other teams as a result.


