

Monthly Summary

Nyati team patrolled at Mathae, Power line, Tundani, Tiva Umbi and Gazi area, and later went on their off break of 14 days in the month of June.

The team patrolled Mathae area which is a known snaring hotspot and managed to lift snares which targeted both small and medium game. The team extended their patrols to power line area which borders Mathae area and found that snaring on its height and the team was able to rescue two snared dikdiks.

Umbi area is known zone for commercial logging and in this regard, the Nyati team concentrated much of its patrols around this area and managed to apprehend two loggers who were using power saw to cut down big trees. This was a worrying discovery since using a power saw is a much faster way of cutting down trees than using an axe.

Gazi area is one of the known hot spot area. And it turned out that this area became the key entry and exit point of poachers from the northern area, after points and sections were secured. The team also realized that poachers were using this area as their safe way in and out of the park. This compelled the team to stay up on their heels by laying ambushes on the poachers' paths and successfully managed to apprehend four charcoal burners.






