DE-SNARING REPORT DECEMBER 2013 ZIWANI/SIMBA TEAM



Ziwani/Simba Team Patrol Report for December, 2013

Monthly Summary

The Ziwani Team, lead by Joseph M, focused their patrols on the central area of the Tsavos where the ranches nd the parks all meet. These are areas where wildlife and communities come into contact as thre are few boundaries. Mbulia Ranch, Kishushe Ranch and Lumo are a handful of examples. Few numbers of snares were recovered (13). Six charcoal kilns were destroyed along with two shooting platforms and three poachers' hideouts.


